SUBJECT: **October 22, 2020 Steering Committee Meeting**

The next meeting of the Three Corners Steering Committee is scheduled for October 22, 2020. With the addition of five new members to the committee, staff is requesting to present an overview and status of the planning process for the Three Corners Project and the next steps in the project.

Project Overview

To date, planning for Three Corners has involved significant community participation through speakupverobeach.com website to solicit community ideas, site tours in January 2020, and a weeklong design charrette to prepare scenarios based on the ideas submitted from the community. The result was five scenarios prepared by the City's planning consultant, DPZ CoDesign that ranged from minimal to maximum development on the site. On February 25, the steering committee reviewed the scenarios and confirmed a balanced development program for the site. This plan became the basis for the steering committee's recommended master concept plan for the site with a few modifications. On June 16, 2020, the steering committee recommended the master concept plan to City Council based on the plan from the charrette.

Based on the recommendation from the planning consultant to consider a plan based on changes to urban design theories because of the COVID-19 pandemic, City Council did not approve the master concept plan and instead the planning consultant prepared a scenario for the site based on the impact of the pandemic. On July 31, 2020, the steering committee reviewed the post-pandemic scenario and recommended it as the master concept plan for the site. On August 18, 2020, the City Council held a hearing to approve the master concept plan. Based on community concerns about the changes to the plan since the charrette, City Council did not approve a master concept plan and instead requested the steering committee to further analyze the scenarios for the Three Corners, including the post-pandemic scenarios and recommend a master concept plan.

Next Steps

Staff will present and review the following aspects of the plan with the steering committee over several meetings over the next few months:

- Review the project goals and planning premises
- Review feedback from the development community on the feasibility of the plans
- Review the scenarios, including the post-pandemic plans.

The draft Three Corners, Vero Beach Report and post-pandemic plans are posted to the Three Corners page of the City's website.
